Health and Safety Policy for Limitless Training Club Alternative Provision

Introduction

At LTC, we are committed to ensuring the health, safety, and well-being of all members of our school community, including students, staff, visitors, and contractors. 2. All Staff:

- All staff members are responsible for taking reasonable care of their own health and safety, as well
 as the health and safety of others, including students, visitors, and colleagues.
- They will carry out regular risk assessments and review health and safety practices to ensure continuous improvement.
- Staff must follow LTC procedures, report any hazards or safety concerns, and cooperate with health and safety training initiatives.
- Staff are responsible for ensuring that students are aware of health and safety guidelines and that they are supervised appropriately at all times.

1. Students:

 Students are expected to take reasonable care of their own health and safety and follow the health and safety instructions given by staff.

Health and Safety Arrangements

1. Risk Assessment:

- Any equipment that is found to be unsafe will be removed from use immediately and replaced or repaired.

1. Health and Well-Being:

- Staff will be encouraged to maintain a healthy work-life balance, and support will be provided for staff experiencing health challenges.
